This Registration Statement on Form S-8 (this "Registration Statement") is being filed for the purpose of registering an additional 500,000 shares of common stock, par value \$0.01 per share ("Common Stock"), of StarTek, Inc. (the "Company") to be issued pursuant to the StarTek, Inc. 2008 Equity Incentive Plan, as amended and restated June 14, 2016 (the "Plan"). The Company registered 1,174,298 shares of Common Stock for issuance under the Plan on a Registration Statement on Form S-8 (File No. 333-150634) (the "Initial Plan Registration Statement"), filed with the Securities and Exchange Commission (the "Commission") on May 5, 2008, and an additional 500,000 shares of Common Stock on a Registration Statement on Form S-8 (File No. 333-195801), filed with the Commission on May 8, 2014, and an additional 250,000 shares of Common Stock on a Registration Statement on Form S-8 (File No. 333-213039), filed with the Commission on August 10, 2016. In accordance with Section E of the General Instructions to Form S-8, the Initial Plan Registration Statement previously filed with the Commission relating to the Plan is incorporated herein by reference, except that provisions contained in Part II of the Initial Plan Registration Statement are modified as set forth herein.
